WAUKESHA USBC WOMEN'S TOURNAMENT

- 1. **QUALIFICATION:** To qualify to bowl, entries will be open to all current members of Waukesha USBC (the Association) who have bowled a minimum of nine (9) games in one certified league in the Association during the current league season. Bowlers from other Associations may bowl in the Tournament but must pay the \$10.00 Waukesha Association membership fee.
- 2. **AVERAGE:** Entering average will be based on the following criteria: 1) Last year's highest USBC/youth/collegiate book average of twenty-one (21) games or more in a Regular league (not a Challenge or Sport league) in ANY Association must be used. If the bowler does not have an average in a Regular league, a Challenge league or Sport league average may be used and will be adjusted using the USBC adjustment chart. 2) If no twenty-one (21) game average from the priorseason, a composite average from the prior season may be used if the bowler has at least twenty-one (21) games bowled in two (2) or more leagues. 3) If the bowler cannot meet the requirements of 1 or 2, the bowler may use their highest 21-game average from the current season in any association. **Verification of averages must be provided at time of check in**. Unverified averages will bowl scratch. Failure to use correct average, USBC Rule 319A-3 will apply. Rules 319B, 319C, 319D & 319E will apply. Rerates will be up to the tournament director's discretion. An entrant who has a current average for twenty-one (21) games or more that is ten (10) pins or more higher than their prior season's average shall use the current season's average in the tournament.
- 3. **ENTRY FORMS:** All entries will be accepted and scheduled on a first paid and lane availability basis. Any teams wishing to bowl together must submit their entries together. Tournament management reserves the right to cancel below-minimum squads no sooner than seventy-two (72) hours before start of said squad and/or to add squads as the need arises.
- 4. CHECK IN: Check in will begin forty-five (45) minutes prior to assigned bowling time. Tournament management will assign lanes for all scheduled events.
- 5. **SUBSTITUTES:** USBC certified substitutes are allowed when a replacement is necessary. (See rule #1). A tournament official must be advised of substitutes prior to the start of bowling. In case of an emergency after a game has started, a substitute, if available, shall be allowed in the doubles event only. The combined scores will count in the doubles event. If no substitute is available, only the actual score of the frames bowled shall count. The lineup will be the same as shown on the entry form. Substitutes will bowl in the position of the bowler being replaced. Paid All Events are NOT transferable, unless the substitute replaces the original entrant in all three events and the transfer is made prior to the time they participate in any event. PACERS ARE NOT PERMITTED.
- 6. **TOURNAMENT MUST AND WILL START ON TIME:** Eight (8) minutes of practice will be allotted prior to the start of the team event, and six (6) minutes of practice will be allotted prior to the start the doubles event. There will be no practice prior to the start of the singles event. Absent or late bowlers will receive zero (0) pins for each frame missed.
- 7. **DIVISIONS AND HANDICAP:** The tournament shall be classified and handicapped in one (1) division: 7A. Bowlers with an average of 230 or higher will bowl scratch with no penalties.

- 8. **TEAMS:** Bowlers may bowl in the Team Event an unlimited number of times; however, in order to cash more than once, two (2) members of the team must be changed and USBC Rule 315b will apply. Teams may consist of three (3) Waukesha USBC certified bowlers and one (1) bowler from another Association. Bowlers from another Association must pay the \$10 Waukesha Association membership fee. Bowlers may only bowl once in the team, doubles, and singles events. Doubles will be bowled before singles. If bowling Doubles in the tournament, you must also enter Singles in the tournament. The number of players classified as PWBA exempt members is limited to one (1) such player on a team or doubles pair.
- 9. **PRIZE MONEY:** Prize money paid into each event will be returned 100% to the winners with at least: one (1) in five (5) for each event. Bowling fee \$10 per 3 games and \$2 expense fee per event.
- 10. NO FEES RETURNED: USBC rule 314 applies, no fees returned.
- 11. **CERTIFICATION:** The United States Bowling Congress (USBC) will certify the Tournament, and USBC rules will apply. If any disputes arise, not covered by the tournament rules listed, rule 329 applies. Errors in scoring must be reported to the tournament director within twenty-four (24) hours. The decision of the Tournament Director will be final unless an appeal is made in accordance with Rule 329.
- 12. **DELAY OF GAME:** USBC Rule 11 Forfeit Delay of Game will be enforced. Bowlers must bowl when it is their turn. Smoke breaks are not permitted.
- 13. Reservations: All reservations will be held for only 2 weeks until payment received, reservations are due no later than 30 days prior to tournament starting date. Entries will be accepted in the final month with payment with entry form and will be based on availability.
