MIXED DOUBLES TOURNAMENT

- 1. **QUALIFICATION:** To qualify to bowl, entries will be open to all members of the Waukesha USBC who have bowled a minimum of fifteen (15) verified games in one certified league in the Waukesha USBC Association during the current league season. One (1) player must be a certified member of the Waukesha Association. **If a player is certified in another association they may bowl, however, they must pay the local Waukesha Association fee of \$10.00. If a bowler is not certified in any association, they may bowl, however, they must pay a "Participation" fee of \$5.00.**
- 2. **AVERAGE:** Entering average will be based on the following criteria: 1) Last year's highest USBC/youth/collegiate book average of twenty-one (21) games or more in a Regular league (not a Challenge or Sport league) in ANY Association must be used. If the bowler does not have an average in a Regular league, a Challenge league or Sport league average may be used and will be adjusted using the USBC adjustment chart. 2) If no twenty-one (21) game average from the 2020-2021 season, a composite average from the 2020-2021 season may be used if the bowler has at least twenty-one (21) games bowled in two (2) or more leagues. 3) If the bowler cannot meet the requirements of 1 or 2, the bowler may use their highest 21-game average from the current season in any association. 5. **BOWLERS WITH NO AVERAGES,** men will enter at 180 and women at 150. **Verification of averages must be provided at time of check in**. Un-verified averages will bowl scratch. Failure to use correct average, USBC Rule 319A-3 will apply. Rules 319B, 319C, 319D & 319E will apply. Re-rates will be up to the tournament director's discretion. An entrant who has a current average for twenty-one (21) games or more that is ten (10) pins or more higher than their prior season's average shall use the current season's average in the tournament.
- 3. HANDICAP: Handicap is 100% of the difference between 460 and the bowlers' combined averages.
- 4. **CHECK IN**: Check in will begin forty-five (45) minutes prior to assigned bowling time. Tournament management will assign lanes for all scheduled events.
- 5. **TOURNAMENT MUST AND WILL START ON TIME:** Lanes will be turned on for six (6) minutes of practice. Absent or late bowlers will receive zero (0) pins for each frame missed.
- 6. **TEAMS:** Teams will consist of one (1) woman and one (1) man. Teams may bowl multiple times in the tournament, but the team may only cash once using the highest score.
- 7. **TIES:** In the case of a tie for first place in any category, co-champions will be declared. In the event of ties, all prize money will be equally shared.
- 8. **PRIZE FUND:** Each event will have its own prize fund with 100% return on prize money guaranteed. Prize ratio is one (1) in five (5) ratio for the doubles event and one (1) in five (5) ratio for the optional singles event.
- 9. NO FEES RETURNED: Rule 314 applies: No fees returned after dates have been assigned.
- 10. **CERTIFICATION:** The United States Bowling Congress (USBC) will certify the Tournament, and USBC rules will apply. In the event that any disputes arise, not covered by the tournament rules listed, rule 329 applies. Errors in scoring must be reported to the Tournament Director within twenty-four (24) hours. The decision of the Tournament Director will be final unless an appeal is made in accordance with Rule 329.
- 11. **DELAY OF GAME:** USBC Rule 11 Forfeit Delay of Game will be enforced. Bowlers must bowl when it is their turn. Smoke breaks are not permitted. Zero (0) pins will be given for each frame a bowler misses without approval from a tournament official.
- 12. **Reservations:** All reservations will be held for only 2 weeks until payment received, reservations are due no later than 30 days prior to tournament starting date. Entries will be accepted in the final month with payment with entry form and will be based on availability.
